
OFFICIAL GAME RULES

Article I. ORGANIZATION

CONSORCI CATALAN FILMS & TV, a public institution under the Generalitat de Catalunya (hereinafter referred to as either "**The Organizing Institution**" or "**CATALAN FILMS & TV**"), with registered address at c/ Mestre Nicolau, 23, entresòl - 08021 Barcelona, Catalonia - Spain, is organizing a free Game in the form of a draw. Participation is free, with no purchase necessary, and will be open between 14th May and 27th June 2008, in two sessions, to be held during the Cannes International Film Festival, from 14th to 25th May 2008 and the Sunny Side of the Doc Festival in La Rochelle from 24th to 27th June 2008 (hereinafter referred to as the "**Festivals**"). The grand prize of the draw is a weekend for two during the 41st celebration of the Sitges International Film Festival of Catalonia, which will be held between 2nd and 14th October 2008.

To take part in this Game, participants will need to visit the CATALAN FILMS & TV stand, which will be present at both of the markets of the aforementioned Festivals.

These Rules define the applicable legal regulations for this Game.

Article II. PARTICIPATION

Participation is free, with no purchase necessary, and is open to anyone over age 18, with the exception of staff members of the Organizing Institution, and generally speaking, the staff members of any other institutions involved in the organization of this Game.

Article III. TERM AND PRINCIPLE

To take part in the draw, each participant must insert a business card with his/her first name, surname and complete personal contact information (address, street name and number, town or city, postal code and e-mail address) into the sealed box specially designed for the Game, which will be found at the CATALAN FILMS & TV stand.

A random draw will be held the first week of July 2008 by the Court Bailiff Mr. Bobin, - 18 rue Montmartre 75001 Paris – to determine the winner from among all the participants that have inserted business cards into the aforementioned box.

The winner authorises CATALAN FILMS & TV to publish his/her name at the institution's website, located at www.catalanfilms.cat, as well as in its Newsletter. The winner's name will therefore be posted on the foregoing internet website and in the Newsletter following the drawing.

At the latest, 4 weeks after the draw, the winner will receive confirmation of the Prize and the details of the trip (including the available items that make up the Prize), set forth in Article 4 of these Rules, which CATALAN FILMS & TV shall send by means of electronic mail and express courier to the address specified for such purpose on the aforementioned business card.

The prize winner shall furnish CATALAN FILMS & TV with the full details of the person he/she has chosen to accompany him/her on the trip, within the four weeks following notification of the Prize, to facilitate all necessary reservations and authorization, accordingly. The person selected to accompany the winner must reside in the same country as the prize winner.

If CATALAN FILMS & TV does not receive this information within the established term or if the confirmation of the Prize and the details of the trip are returned to the Game's Organizing Institution, whether by the postal service or by the express courier provider within any of the established terms, it shall be understood that the winner has forfeited his/her prize, providing that such failure stems from a cause imputable to the latter (for example: that he/she no longer resides at the indicated address).

Any Prize that is not claimed within the maximum term of two months following the date of the draw will be deemed as forfeited by the winner.

Article IV. THE PRIZE

A trip for two people to Sitges during the 41st celebration of the International Film Festival of Catalonia, which will be held in Sitges, Barcelona, from 2nd to 14th October 2008 (also referred to as the "**Sitges Film Festival** ") with an overall net price value of €2500 including all taxes (beyond the assumed air transport expenses) (also referred to as "**the Prize**").

The stay for two people includes:

- Air transport to Barcelona on regular flights of Iberia Airlines or on any other airline, in Economy Class or similar.
- Air and security taxes.
- Accommodations for a two-night stay in a standard double room at the Hotel Melia (4-star hotel, in Sitges) or similar, including breakfast and half board.
- Airport - hotel - airport transportation.
- Festival passes providing access to the screenings and certain events organized by either CATALAN FILMS & TV or the Sitges Festival Organizers.
- Insurance coverage for medical evacuation, provided by La Compagnie Européenne d'Assurances.

The stay does not include:

- Meals, beverages, gratuities for guides and drivers, and personal expenses.
- [Additional insurance for cancellations and loss of luggage, with La Compagnie Européenne d'Assurances: 2. 5% of the total amount].
- Expenses corresponding to formalities (passport, etc.).
- Any and all services not mentioned in the above section titled "The stay includes ".
- Any expenses corresponding to transportation from the home(s) of the winner and his/her travel companion to and from the airport of origin.

Important – for information / CATALAN FILMS & TV cannot be held responsible for the

inaccuracy, imprecision or false nature of the personal data provided by the winner at the time of his/her participation in the Game or for the inaccuracy or imprecision of the personal data that he/she provides regarding the person chosen to accompany him/her, as a result of the notification of his/her Prize. Such data shall be controlled by the police, customs authorities or any other competent administrative authorities within the country of residence of the winner and his/her chosen travel companion, in any and all countries of transit on the way to Spain and in Spain. The winner and his/her travel companion, duly informed by the former, acknowledge and agree that in order to receive and make use of the Prize they must hold all the valid relevant identification documentation in their country of origin (passport, including if necessary any required visas, national identity card or equivalent) that permit entry into Spain. For such purpose, they shall directly undertake any and all relevant formalities required by the competent authorities. Accordingly, CATALAN FILMS & TV is totally exempt of any and all liability to the winner and his/her chosen travel companion, stemming from the flawed, incomplete nature or expiration of the aforementioned identification documents, which would result in the competent authorities' prohibition of the winner and his/her chosen companion from effectively making use of the Prize.

Under no circumstance is the winner entitled to lodge any dispute or challenge of any nature whatsoever or to convert the Prize for its exchange value in any manner, or to substitute or exchange it for any reason whatsoever.

Notwithstanding the foregoing, if the circumstances so require, CATALAN FILMS & TV reserves the right to substitute the Prize with another prize of equal or greater value.

CATALAN FILMS & TV declines any and all liability relating to the quality and /or condition of the Prize on delivery.

Article V. CONDITIONS FOR PARTICIPATION

Each participant may take part one time only throughout the duration of the Game within the term set forth in Article 1 herein above (under the same name, same address, same e-mail, same IP address).

Anyone who wishes to play is required to follow the instructions given to him/her at the CATALAN FILMS & TV stand.

All information appearing on the business card which the participant inserts into the box will be conveyed for processing in the draw for the Prize.

Any participant who has entered more than one e-mail with the same address and the same name will be disqualified and deemed ineligible to opt for the Prize that otherwise would have been granted to him/her.

Any false registrations (e-mail + incomplete postal addresses) or those carried out in a manner that conflicts with these rules will lead to the participant's disqualification.

CATALAN FILMS & TV will not be held responsible for any faulty e-mail delivery.

CATALAN FILMS & TV reserves the right to verify any information necessary for the purposes set forth herein.

Article VI. ANNOUNCEMENT OF THE WINNER

CATALAN FILMS & TV shall notify the winner directly in writing of the Prize he/she has won, **by electronic mail and express courier.**

It must be born in mind that a participant is identified by the address that he/she has provided when registering. In the event of disputes, only the listings of participants established by CATALAN FILMS & TV will be deemed valid.

Article VII. PUBLICATION OF RESULTS

The information provided by the participant may be used within the scope of computerised processing.

The participant authorises CATALAN FILMS & TV to transmit the first and surname, country of origin and town of residence of the winner for purely computerised purposes, once the winner has given consent thereto pursuant to that set forth in this Article and in accordance with the legislation in force.

In any case, it must be borne in mind that pursuant to the Law, CATALAN FILMS & TV acknowledges the participant's rights of access and rectification regarding his/her personal data.

The participant may request not to appear or to be removed from the file at any time, and will have the rights of access, rectification and cancellation regarding his/her personal data by means of simple request to the address of the Game, in accordance with the applicable European Regulations (EU Directive 95/46/EC of 24th October 1995) and the legislation in force.

Accordingly, the participant has the rights of opposition and rectification regarding his/her personal data.

Thus, he/she may request that any inaccurate, incomplete, equivalent, erroneous or outdated information pertaining thereto be rectified, completed, updated or cancelled.

Article VIII. REIMBURSEMENTS

Participation in this Game is free, with no purchase necessary.

The Game is designed so that the participant does not have to pay any expense directly associated with his/her participation therein, which does not require any connection to the Internet or telephone communication of any nature. Should the need arise to modify or reorganize any of the items that make up the Prize, CATALAN FILMS & TV shall contact the winner directly.

The postage costs assumed in sending the request for the Rules will be reimbursed at the postal rate in force.

The corresponding request must be made in writing to the following address: c/ Mestre Nicolau, 23, entresòl - 08021 Barcelona, Catalonia – Spain. Such request must include the full contact information (first and surnames, address, postal code, town).

No requests for the reimbursement of postal charges will be honoured if the conditions set forth herein above are not met, and telephone requests will not be accepted.

Requests for the reimbursement of postal charges will be honoured within a term of 4 weeks, to be counted as of receipt of the written request.

Reimbursement of postal charges corresponding to the request for the Rules is limited to one per company or institution (same name, same address).

LIABILITY

CATALAN FILMS & TV cannot be held responsible for a participant's entry data that for any reason is not received and that does not fall within the scope of liability of the former, or for data that arrives in a condition that is illegible or impossible to process.

All information provided by the winner, and particularly his/her contact information, will be deemed null and void and will not be taken into consideration if such information presents any inaccuracies.

CATALAN FILMS & TV cannot be held responsible for losses or damages of any nature (personal, physical, material, financial or other) suffered by a participant when taking part in the Game.

It is hereby specifically noted that CATALAN FILMS & TV cannot be held responsible for direct or indirect losses or damages of any type stemming from an interruption, malfunction of any nature whatsoever, the suspension or termination of the Game. Nor will CATALAN FILMS & TV be held responsible for any direct or indirect damage that may arise from a case of force majeure, for any reason whatsoever.

The participant acknowledges that participation in this Game is exclusively at his/her own risk.

CATALAN FILMS & TV would not be held responsible in the event of the obligation to modify, shorten or cancel this Game as a result of force majeure or any other causes beyond its control.

In all cases, the Organizing Institution reserves the right to extend the term of participation.

Additional clauses, or in the event of force majeure, modifications to these Rules may possibly be applied during the course of this Game.

Such modifications shall be considered as annexes to these Rules and kept on record in the Office of the Court Bailiff.

It is agreed that CATALAN FILMS & TV may use, particularly for the purpose of proof, any act, event or omission of the data that it has established, received or kept directly or indirectly, during the course of the Game.

Thus, any items that are considered to be proof, if presented by the Organizing Institution as a means of proof in contentious proceedings or those of another nature, will be admissible, valid and opposable among the parties in the same manner, under the same conditions and with the same testimonial force as those of any document that may be established, received or held in writing.

Article IX. APPLICABLE LAW AND EXCLUSION

In a word, it is expressly agreed that the applicable Law governing this Game is French Law.

CATALAN FILMS & TV reserves the right to exclude from participation any individuals who disrupt the progress of the Game.

CATALAN FILMS & TV reserves the right to use any resources necessary, and particularly that of bringing legal action against anyone who makes use of cheating, fraud, falsification or the disruption of the operations described herein or who has attempted to engage in such activities.

Any participant deemed by CATALAN FILMS & TV as having disrupted the Game in any of the aforementioned manners will legally lose all rights to obtain any prize whatsoever, and no claims corresponding thereto will be accepted.

Article X. FORCE MAJEURE

CATALAN FILMS & TV reserves the right, particularly in the case of urgent cause, to shorten, extend or cancel this Game and/or either of its sessions, whether partially or fully, if the circumstances so require, and shall not be held liable therefor.

Notwithstanding the foregoing, such modifications may at all times be subject to previous notification by means of all the appropriate channels, and particularly by means of the CATALAN FILMS & TV website.

CATALAN FILMS & TV reserves the right to momentarily suspend the possibility of participating in the Game if it or the organizer cannot ensure the necessary continuity of the progress of the Game. The Organizing Institution may at all times in the case of force majeure, chance or extraordinary circumstance (fire, flood, natural catastrophe, intrusion, ill will within the computer system, strike, uncertainty regarding the financial and technical stability of the Game, the breakdown and obstruction of the telecommunications networks, damages caused by viruses that cannot be eliminated by the existing security systems in the market, legal or regulatory obligations or those of a public order enforced by the competent authorities which effects by nature considerably modify these Game Rules, or any other incident of force majeure or chance affecting either of the two Festivals in the sense set forth in Article 1148 of the Civil Code) partially or completely discontinue the Game, even if such action is the result of a cause stemming from its own responsibility (providing such is a case of good faith).

In the event of force majeure, this Game will be cancelled and the participants or winners will not be entitled to claim any indemnity whatsoever therefor.

Article XI. CLAIMS

Any disputes or claims in relation to this Game will solely be taken into account if sent prior to 30th June 2008, and must be postmarked by such date.

Any disputes or claims in relation to this Game must be presented in writing and sent in a simple letter to CATALAN FILMS & TV at the address set forth in Article 1 of these rules.

Such letter must specify the precise date of participation in the Game, the complete contact information of the participant and the exact reason for the claim. No other channels of opposition or claim will be taken into account.

CATALAN FILMS & TV will be the sole authority to decide on any problems that may arise in the application or interpretation of these Rules or in the case of any ambiguity relating thereto during the course of this Game.

Article XII. ACCEPTANCE OF THESE RULES

Any and all participation in this Game automatically implies the pure and simple acceptance of these Rules. The French version is the only valid and authentic version of these Rules; however CATALAN FILMS & TV may make translations thereof available, alongside the original version.
